6. You are responsible for your site clean-up. Dumpsters will be on site to dispose trash. (Please do not dump any grease on grass). Any vendor found to be in violation will not be allowed any future participation.
7. All vendors except non-profit vendors that provide proper documentation are required by law to collect and remit all state and local sale taxes to the Georgia Department of Revue. This is the vendors sole responsibility.
8. Festival ends after the Fireworks show which starts at or around 9:45pm. Vendors will have until 12:00 midnight to break down and clean up.
9. Pictures and videos will be taken at this event for promotional purposes and may be utilized on any media outlets, websites and social media outlets in the future.
